This Agreement is made on August 12, 2013, between Richland County School District One, hereinafter referred to as the "District" and "VISIONS MADE PLAIN", hereinafter referred to as "VISIONS MADE PLAIN".

Article I Contract Period/Contract Renewal

The District and "VISIONS MADE PLAIN" hereby enter into this Agreement for a term commencing September 9, 2013 through April 30, 2014 subject to the approval of a 21st Century Grant. This Agreement will need to be renewed annually subject to the approval of a 21st Century Grant.

Article II Obligations of "VISIONS MADE PLAIN"

- A. Describe the services being provided in this section.
- B. "VISIONS MADE PLAIN" shall provide to Keenan High School's program from September 2, 2013 to April 30, 2014 at 4 hours per week for (27) weeks. These services are offered at a true cost of \$5,000. The school will provide supplies, a classroom, and transportation for activities. "VISIONS MADE PLAIN" will under the direction of:

Daryn Murphy, CEO "VISIONS MADE PLAIN" will offer a focus on computer information technology that will enhance and expand student's knowledge and skills and examine the impact and power of online communication to include:

- Best Practices on how to use computer information technology and social media such as Facebook, Twitter and Wordpress for professional growth and development. Students will develop the following:
 - Video production; a powerpoint presentation; and computer-generated graphics.
- The parents will receive a free training session during the Fall and Spring semester.

- C. "VISIONS MADE PLAIN" agrees to conduct criminal background checks and a sex offender registry check on volunteers serving as a "VISIONS MADE PLAIN" provider/volunteer that has been matched with a Richland School District One student. "VISIONS MADE PLAIN" paperwork asks for parent/guardian permission for providers/volunteers to visit students during the school day (in non-academic periods). "VISIONS MADE PLAIN" shall provide evidence that a satisfactory background check has been conducted.
- D. "VISIONS MADE PLAIN" providers/volunteers shall provide service for "VISIONS MADE PLAIN" site-based arts-focused program at Keenan High School.
- E. (1) "VISIONS MADE PLAIN" providers/volunteers will not be compensated by the District or "VISIONS MADE PLAIN".
 - (2) "VISIONS MADE PLAIN" will receive payments from grant proceeds as negotiated and provided through grant services.
- F. "VISIONS MADE PLAIN", providers/volunteers shall be responsible for providing their own transportation to conduct their service. Transportation for students may be provided through grant services.
- G. As a partner, "VISIONS MADE PLAIN" shall agree to abide by all relevant District policies and regulations including but not limited to, the School Board Policies and Procedures. The District policies can be found on the District's Web site at www.richlandone.org.
- H. "VISIONS MADE PLAIN" shall comply with all requirements of applicable Federal and State laws including but not limited to, the Civil Rights Act of 1964, Section 504 of the Rehabilitations Act of 1973, The Age Discrimination Act of 1975, the American with Disabilities Act of 1990, and the Drug Free Workplace Act.
- I. No services under this Agreement shall be provided by anyone other than providers/volunteers with "VISIONS MADE PLAIN".
- J. "VISIONS MADE PLAIN" shall conduct criminal background checks for its providers/volunteers serving Richland One

- students and obtain appropriate parent permission and school referrals.
- K. Representatives of "VISIONS MADE PLAIN" shall provide orientation, placement and monitoring for all "VISIONS MADE PLAIN" providers/volunteers.
- L. "VISIONS MADE PLAIN" shall adhere to all confidentiality regulations promulgated by Federal, State or local governments, with regard to the treatment of student records, as well as those governing the information retained and distributed by the District.
- M. "VISIONS MADE PLAIN" agrees that it will indemnify and hold harmless the District, its servants, agents and employees, from any and all liability, damage, expense, causes of action, suits, claims or judgments arising from injury to person(s) or personal property or otherwise which arises out of the act, failure to act, or negligence of volunteers, its agents and employees, in connection with or arising out of the activity which is the subject of this Agreement.
- N. Further, "VISIONS MADE PLAIN" agrees to maintain at its own expense a commercial general liability policy with coverage sufficient to meet the limits under the South Carolina Tort Claims Act in Section 15-78-120(a)(1) and (2), as may be amended, or a comparable self-funded liability program. "VISIONS MADE PLAIN" shall provide a certificate of insurance or written proof of its self-funded insurance program.
- O. "VISIONS MADE PLAIN" shall certify in writing and/or present satisfactory evidence that all personnel and members assigned to the schools have had background checks conducted satisfactorily.

Article III Responsibilities of the District

A. The District will serve as the fiscal agent for funds received pursuant to the grant.

- B. The District will be responsible for the determining appropriate facility space for the service.
- C. The District will designate appropriate District personnel to coordinate the relationship/project.

The responsibilities of such personnel shall include:

- Designate providers/volunteers as approved in the V-Soft system;
- Report providers/volunteer information tracked by V-Soft at the end of each marking period;
- Serve as a point of contact for "VISIONS MADE PLAIN" staff.

SPECIAL TERMS AND CONDITIONS

- A. If the District should incur a property loss as a result of the use of a school by "VISIONS MADE PLAIN", shall be assessed an amount which shall cover the damage and related costs and shall reimburse the District within thirty (30) days after receipt of an itemized statement of such costs.
- B. If a public announcement is made to the effect that District facilities/schools will be closed for the day because of hazardous weather conditions or other extenuating circumstances, the Richland One volunteer programs partnership with "VISIONS MADE PLAIN" will also be closed.
- C. All parties agree to pursue additional funding to sustain the program described herein beyond the funding cycle for 21st Century Grants.
- D. This agreement is to be governed by the laws of the State of South Carolina.

ADDITIONAL TERMS AND CONDITIONS

CONTRACT LIMITATIONS: No sales may be made pursuant to this contract for any item or service that is not expressly listed. No sales may be made pursuant to this contract after expiration of this contract. Violation of this provision may result in termination of this contract and may subject contractor to suspension or debarment.

CONTRACTOR PERSONNEL: The Contractor shall enforce strict discipline and good order among the Contractor's employees and other persons carrying out the Contract. The Contractor shall not permit employment of unfit persons or persons not skilled in tasks assigned to them.

DRUG FREE WORK PLACE CERTIFICATION: By submitting an Offer, Contractor certifies that, if awarded a contract, Contractor will comply with all applicable provisions of the Drug-Free Workplace Act, Title 44, Chapter 107 of the South Carolina Code of Laws, as amended.

PAYMENT FOR GOODS & SERVICES: Payment for goods and services received by the District shall be processed in accordance with the Richland County School District One Procurement Code. Contractor shall submit quarterly invoices by the last day of each nine week session. Payment shall be rendered thirty (30) days after receipt of invoice.

PUBLICITY: Contractor shall not publish any comments or quotes by District employees, or include the District in either news releases or a published list of customers, without the prior written approval of the Director for Extended Day Services. Contractor shall not produce any pictures, videos or recording of any type while on District property without prior written approval by the school's Principal and also Director of Extended Day Services. Contractor shall also prohibit use of any photographic, audio or video recording devices by students.

PRIVACY – WEB SERVICES: Contractor shall agree that any information acquired about individuals or businesses as a result of your performance of this contract shall not be retained beyond the end of the term of the contract without the express written consent of the District. Such information shall never be sold, traded, or released to another entity, including affiliates, and shall not be used for any purpose other than performing this contract. Upon request, contractor shall provide written confirmation of compliance with this clause.

PURCHASE ORDERS: Contractor shall not perform any work prior to the receipt of a purchase order from Richland County School District One. The District shall order any supplies or services to be furnished under this contract by issuing a purchase order. Purchase orders may be used to elect any options available under this contract, e.g., quantity, item, delivery date, payment method, but are subject to all terms and conditions of this contract. Purchase orders may be electronic. No particular form is required. An order placed pursuant to the purchasing card provision qualifies as a purchase order.

RELATIONSHIP OF THE PARTIES: Neither party is an employee, agent, partner, or a joint venture of the other. Neither party has the right or ability to bind

the other to any agreement with a third party or to incur any obligation or liability on behalf of the other party.

STATUS OF CONTRACTOR - It is understood and agreed that contractor (including contractor's employees) is an independent contractor and that no relationship of employer-employee exists between the parties hereto. Contractor's assigned personnel shall not be entitled to any benefits payable to employees of the District. Richland County School District One is not required to make any deductions or withholdings from the compensation payable to contractor under the provisions of this agreement; and, as an independent contractor, contractor hereby indemnifies and holds the District harmless from any and all claims that may be made against the District based upon any contention by any third party that an employer-employee relationship exists by reason of this agreement.

- It is further understood and agreed by the parties hereto that contractor, in the performance of its obligations herein, is subject to the control or direction of Richland County School District One as to the designation of tasks to be performed, the results to be accomplished by the services herein agreed to be rendered and performed, and not the means, methods, or sequence used by contractor for accomplishing the results.
- If, in the performance of this agreement, any third parties are employed by contractor, such person(s) shall be entirely and exclusively under the direction, supervision, and control of contractor. All terms of employment, including hours, wages, working conditions, discipline, hiring, and discharging, or any other terms or employment or requirements of law, shall be determined by contractor.
- It is further understood and agreed that contractor must issue w-2 and 941 forms for income and employment tax purposes, for all of contractors assigned personnel under the terms and conditions of this agreement.
- Contractor shall maintain current background checks on all employees working with or on District premises. These checks shall include but shall not be limited to appropriate licensure with SLED Criminal Background checks, and state and national sexual offender registries. Contractor shall meet all qualifications as set forth by federal, state, and local government entities. Upon entry to every Richland County School District One facility, guests are required to surrender a state issued identification to be scanned in a visitor tracking software application which will check sexoffender registries. If guest is found to be on a registry, they will be asked to immediately leave the premises and the appropriate law enforcement agency will be notified.
- Contractor and all agents and employees shall be subject to all policies, regulations and rules set forth by the District's Board of Commissioners and shall require students to adhere to appropriate student conduct set forth by District.

TERMINATION

Either party may terminate this Agreement at any time by giving written notice of said termination, should the other party fail to substantially perform its obligations under the Agreement and fail to cure such default within 15 days after written notice thereof. Either party may terminate this Agreement without cause at any time upon mutual agreement between the parties or by giving the other party at least thirty (30) days advance, written notice.
